#### ARTICLES OF INCORPORATION

OF MacTan Corporation

The undersigned incorporator, for the purpose of forming a corporation under the ISANG ARY OF STATE Business Corporation Act and Professional Service Corporation Act 1994 compiled under FIDAHO the authority of Pete T. Cenarrusa, Secretary of State, Boise, Idaho, (referred to herein as "The Act") hereby adopts the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of the corporation shall be MacTan Corporation.

#### ARTICLE II - DURATION

The duration of the corporation shall be perpetual. The business will cease to conduct business only if: 1) The Board of Directors recommends and approves to dissolve it, or 2) All the shareholders, by written consent, choose to cease business.

Each Common Stock share will have voting rights equal to one vote per share.
