## ARTICLES OF INCORPORATION

## FABRIC LAND, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is FABRIC LAND, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are for the wholesale and retail sale and resale of fabrics, drapery and other piece goods, porcelains, domestics, and other goods, and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is fifty thousand (50,000) shares at a par value of one dollar (\$1.00) per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: The address of the initial registered office of the corporation is 990 Yellowstone Ave., Pocatello, Idaho 83201, and the name of its initial registered agent at such address is Ann Evans.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are the following:
