


KNOW ALL MEN BY THESE PRESENTS, That THE WASHINGTON WATER POWER COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Washington, desiring to entitle itself to transact business in the State of Idaho by a compliance with the requirements of the laws of said state relative to foreign corporations and their rights to transact business therein, has for that purpose as provided by the provisions of Section 2792 of the Civil Code of the State of Idaho, and also for the purpose of complying with Section 10 of Article XI of the Constitution of the State of Idaho, constituted, appointed and designated, and does hereby constitute, appoint and designate THERRETT TOWLES, a citizen of the State of Idaho, residing at Wallace in the County of Shoshone, in which county the principal place of business of this corporation in the State of Idaho is conducted, the Attorney and Agent of this corporation upon whom process issued upon or under any laws of the State of Idaho may be served, and the said Therrett Towles is authorized as such attorney and agent to accept service of summons or other legal process against this corporation, hereby canceling and revoking all previous powers of attorney heretofore given for the same purpose.
