ARTICLES OF INCORPORATION OF IDA-LEW ECONOMIC DEVELOPMENT COUNCIL, INC.

The undersigned, acting as incorporator and initial directors of IDA-LEW ECONOMIC DEVELOPMENT COUNCIL, INC., a nonprofit corporation organized under the Idaho Nonprofit Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I :

The name of the corporation is and shall be:

ARTICLE II:

The period of the corporation's duration is perpetual.

ARTICLE III:

The purpose or purposes for which the corporation is organized are:

Primary purpose: Social welfare purposes, as permitted and defined by Internal Revenue Code § 501(c)(4); and

Secondary purposes: To assist and encourage business and economic development in Idaho County and Lewis County, State of Idaho, and cities located therein, as permitted by Internal Revenue Code § 501(c)(4); and

The transaction of any or all other lawful business, for which nonprofit corporations may be incorporated under the Idaho Nonprofit Corporation Act, as amended, not inconsistent with the primary purpose or Internal Revenue Code § 501(c)(4).

ARTICLE IV:

No individual, private shareholder, director, officer, employee or agent of the Corporation may pay or receive any dividend, distribution or net earnings, or part thereof, from Corporation. The net earnings of the Corporation shall be devoted only to purposes permitted by Internal Revenue Code § 501(c)(4).

ARTICLE V:

The Corporation does not have voting members. The Corporation shall be governed by a Board of Directors, to be qualified and appointed as provided in the bylaws of the Corporation.
