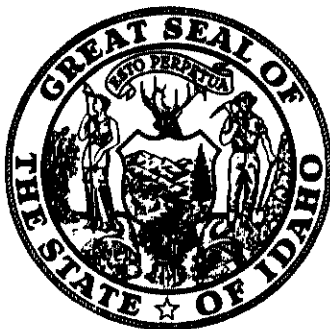
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF  
PARKLINE CORPORATION

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned citizens of the United States of America, being each of full age, have this day voluntarily associated ourselves together for the purpose of forming a business corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

The name of this Corporation shall be PARKLINE CORPORATION.

ARTICLE II

The purposes for which this Corporation is formed are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

This Corporation shall have perpetual duration.

ARTICLE IV

The location and post office address of the initial registered office of this Corporation shall be HCO1, Box 50A, St. Maries, Idaho 83861, and the registered agent shall be TROY A. FAUSETT, HCO1, Box 50A, St. Maries, Idaho 83861; and the Corporation may have such other offices and places of business within or outside the State of Idaho as the directors shall, from time to time, determine.

ARTICLE V

The authorized capital stock which this Corporation shall have authority to issue shall be 1,000,000 shares

of common stock of a single class, all of which shares shall be without par value.

#### ARTICLE VI

The stockholders of the Corporation may provide by agreement, or by resolution duly adopted by the affirmative vote of the holders of not less than two-thirds of the stock outstanding, that sale or transfer of any of the Corporation's stock shall be subject to certain restrictions or limitations, not prohibited by law; provided, however, that no such restriction or limitation shall be binding upon or enforceable against stockholders not having actual notice thereof unless such restriction or limitation shall be fully set forth or incorporated by reference in the certificate evidencing each stockholder's shares.

#### ARTICLE VII

The Board of Directors of this Corporation shall consist of two members, or such greater or lesser number as the Bylaws of the Corporation shall hereafter provide.

#### ARTICLE VIII

The name and post office address of each of the incorporators and members of the initial Board of Directors of this Corporation are as follows:

Said directors shall serve until the first annual meeting of shareholders or until their successors are elected and qualify.

ARTICLE IX

The directors of this Corporation shall not be subject to personal liability to the Corporation's other directors or its stockholders except to the extent specified in I.C. 30-1-54(2).
