## Articles of Incorporation for Medieval Adventures Inc.

STATE OF TOAHOUL I. Unto the Honorable Secretary of State for the State of Idaho; By this be it known that it is proposed that a non-profit corporation to be titled Medieval Adventures Inc. be formed pursuant to current Idaho State laws.

II. Said corporation is to exist in perpetuity unless by action of the Board of Directors and shareholders under Idaho law 30-3-110 and 30-3-111 the Corporation is dissolved.

III. The purpose of said corporation is to provide interactive, cultural, and educational opportunities for groups and individuals to experience and understand their European cultural heritage dating from the Medieval Era. To help achieve this purpose the said corporation will acquire land and build facilities replicating medieval European life.
