# ARTICLES OF AMENDMENT OF

Verlene D. Kaiser and Gary L. Kaiser certify that:

- 1. They are the President and Secretary respectively of Community Home Health, Inc.
- 2. The articles of incorporation of said corporation are amended to read as follows:

#### VIII. Authorized Capital Stock

The aggregate number of shares which the corporation shall issue shall be 500,000 each with no par value, 125,000 shares shall be voting and 375,000 shares shall be non-voting, which said shares shall be common stock, and shall not be subject to assessment. Both voting and non-voting shall have identical rights, and neither voting or non-voting shall have any preferences or special rights with regard to dividends or upon liquidation of the corporation.

- 3. The foregoing amendment of the articles of incorporation has been duly approved by the shareholders and the board of directors of the corporation.
- 4. Prior to this amendment, the corporation was authorized to issue 500,000 shares of common stock with a par value of one penny (\$0.01) per share. Three thousand three hundred thirty-three (3,333) shares were issued and outstanding, thus the stated capital was \$33.33. As a result of this amendment and restatement, the corporation is authorized to issue 500,000 shares of common stock with no par value per share; 125,000 of voting stock and 375,000 of non-voting stock.
