ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF CHRISTIAN CHURCH HOMES OF IDAHO, INC.

The undersigned Corporation (the "Corporation") was formed to own and operate Valley Vista Village ("Facility"), a housing facility developed and financed under Section 221(d)(3) of the National Housing Act and through the ownership and operation of the Facility to provide housing and services to individuals without regard to their ability to pay. The National Benevolent Association of the Christian Church (Disciples of Christ) ("NBA") sponsored the construction and development of the Facility and, as such, is granted certain rights and powers in the Articles of Incorporation of the Corporation (the "Rights and Powers"). Because of changes in the mission and purposes of the NBA, the Corporation and the NBA have agreed that it would be in the best interest of both the Facility and the Corporation for Christian Church Homes of Idaho, Inc. ("CCHI") to become the sponsor and assume the Rights and Powers. CCHI is willing to become the sponsor and assume the Rights and Powers and the Secretary of Housing and Urban Development has consented to the amendment of the Articles of Incorporation and other governing documents of the Corporation in order to (i) name CCHI as the sponsor in the Articles of Incorporation and other governing documents of the Corporation and (ii) provide for CCHI to assume the Rights and Powers in place of the NBA.

In order to accomplish the foregoing, the Articles of Incorporation of the Corporation, as filed with the Secretary of State of the State of Idaho on April 25, 1979, and all amendments thereto (the "Articles of Incorporation"), are amended as follows:

1. All references in the Articles of Incorporation to the names "National Benevolent Association of the Christian Church (Disciples of Christ)" and "National Benevolent Association" are replaced in each place either or any similar reference appears with the name Christian Church Homes of Idaho, Inc. and any reference to "NBA" in the Articles of Incorporation, whether used as a defined term or otherwise, is replaced in each place it appears with "CCHI".
2. Each reference in the Articles of Incorporation to the geographic location of the National Benevolent Association of the Christian Church (Disciples of Christ) is replaced with the State of Idaho.
3. Article 11, Paragraph 1 is stricken in its entirety.
