## ARTICLES OF AMENDMENT TO THE ART B2L#\$1 23 FM 8 24 OF INCORPORATION OF EUCON CORPORATION

Pursuant to the provisions of sections 30-1-59 and 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its Articles of Incorporation:

FIRST: The name of the corporation is now known as "EUCON CORPORATION."

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation on the 21 day of December, 1991, in the manner prescribed by the Idaho Business Corporation Act:

Article First of the Articles of Incorporation which now reads:

#### "FIRST

That the name of the corporation shall be EUCON CORPORATION"

shall be and the same is hereby amended to read as follows:

#### "FIRST

That the name of the corporation shall be DeATLEY COMPANY, INC."

THIRD: The number of the shares of the corporation outstanding at the time of such adoption was 396,213 and the number of shares entitled to vote thereon was 396,213.
