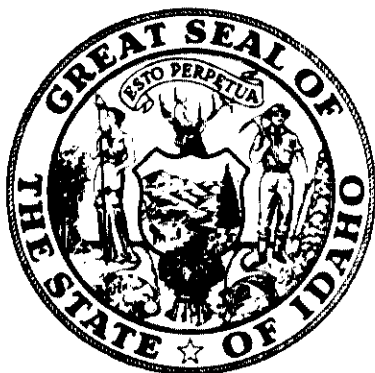

That we, the subscribers, members of Chapel of Praise of Twin Falls, citizens of the county of Twin Falls, and of the State of Idaho, under the provisions of and in accordance with the laws of the State of Idaho pertaining to such matters, do hereby form and incorporate ourselves into a voluntary religious association for the purpose of establishing and maintaining religious worship, and promoting the Gospel of Jesus Christ, and to that end, adopt the following:

ARTICLE I

This corporation shall be known as Chapel of Praise, Incorporated, Twin Falls, Idaho, by which name it shall contract and contracted with, sue and be sued, and transact all of its business.

ARTICLE II

This corporation shall be located in the city of Twin Falls, County of Twin Falls and State of Idaho.

ARTICLE III

This corporation is formed for the purpose of establishing and maintaining religious worship, propagating the Gospel of Jesus Christ through printed and recorded materials, seminars, conferences and related methods, including the establishment and maintenance of Christian day schools, grade schools, high schools and Bible colleges,

ARTICLE IV

This corporation shall exist for a period of fifty (50) years.

ARTICLE V

The registered office of this corporation is 306 Elaine Ave. West, Twin Falls, Idaho. The initial registered agent shall be Rev. Sheldon Slagel, 306 Elaine Ave., Twin Falls, Idaho

ARTICLE VI

This corporation shall own no property of any kind or character except that used for religious purposes. Said corporation shall be without capital stock and the same shall be operated solely for religious purposes, without profit.

No income of this corporation shall be paid out to the members thereof, to the directors or trustees thereof, or to the officers thereof; provided, however, that the corporation may pay compensation in reasonable amount to its members, to its directors or trustees, or to its officers for service rendered.

ARTICLE VII

This corporation shall, within its means and its discretion, provide for the propagation of the Gospel of Christ at home and abroad in accordance with the Great Commission as recorded in St. Mark, chapter 16 beginning with verse 15.

ARTICLE VIII

The officers of this corporation shall be known as the Pastors Advisory Board, and said Board shall consist of not fewer than four, nor more than eight husband-wife advisors, or single male-female advisors.

The advisors term of office shall be a two year term, with one-half of the first Advisory Board being a one year term.

Upon completion of said advisors term in office there shall be a one year waiting period before being eligible to serve another term.

The Advisors shall be put in office by appointment of the President, Vice-President and Secretary.

There shall be an equal number of male/female Advisors.

ARTICLE IX

The following named persons shall constitute the first Pastors Advisory Board of this corporation:

ARTICLE X

The means, assets and income and real property of this corporation shall be managed by the Pastors Advisory Board subject always to the approval of the membership of this corporation.

ARTICLE XI

Any vacancies of office, matters of general business, etc., not specifically covered by the above articles shall be handled by a majority vote of the members present at a duly announced business meeting of the church congregation.

ARTICLE XII

Some of the foundational objectives of Chapel of Praise are:

To correctly and fully proclaim the whole counsel of God according to His Holy Spirit inspired Word.

To help every believer enetr into the presence of God,
to Worship in Spirit and in Truth, to walk in the personal
victory and to be ready for the Second coming of Christ.

To teach and train disciplined Disciples equipped for
effective Kingdom ministry.

To help bring all mankind to Jesus Christ so that He
may save the lost, heal the sick, release the captives and
empower the believers with the Holy Spirit.


ARTICLE XIII


