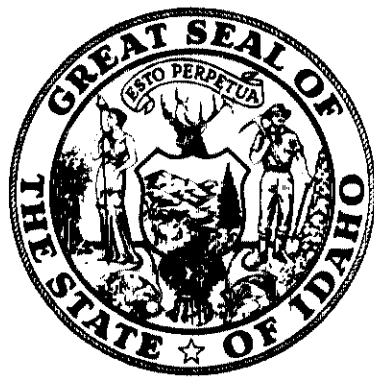

Pursuant to the Idaho Business Corporation Act, Telebankers, Inc., adopts the following Articles of Amendment of its Articles of Incorporation:


1. The present name of the corporation is Telebankers, Inc..
