ARTICLES OF INCORPORATION
of
COEUR D'ALENE LAND COMPANY

We, the undersigned, being natural persons of the age of twenty-one years or more, and subscribers to the shares of the corporation to be organized pursuant hereto, and all citizens of the United States and residents of and domiciled in the State of Idaho, do for the purposes of forming a corporation under the laws of the State of Idaho, hereby adopt the following Articles of Incorporation:

I.

The name of the proposed corporation is

COEUR D'ALENE LAND COMPANY

II.

The purposes of said corporation are to purchase or otherwise acquire lands or properties, including personal properties, contracts for the purchase or sale thereof, buildings, improvements and any other real property of any kind or nature or any interest therein and any personal property, equipment, machinery of any kind or nature necessary or in connection therewith and to contract and undertake in any manner, to pay for the same in cash or by stock, bonds or other obligations of the company and to sell, convey, lease, mortgage, deed of trust, turn or otherwise deal with all or any part of the property of the company.

To develop land or contracts for the purchase or sale of lands acquired by the company, or in which the company is interested, and in particular lay out townsites, plots, establish additions to towns and improve the same by

preparing the same for building purposes, to construct, alter and improve buildings thereon, to plant, pave, drain, irrigate, cultivate, let or lease any of said properties owned by the corporation.

To advance money for all kinds of buildings, tenements and other improvements and to in each and every nature employ and use said property as determined in the best interest of said corporation.

That in addition to the powers above enumerated, said corporation shall in addition thereto have the power to purchase, buy and acquire stock in this corporation or other corporations, to borrow money and give security therefor and to exercise and use all those powers as are granted by 30-114 Idaho Code.

The duration of this corporation shall be perpetual.


