I, the undersigned, being one (1) or more natural persons, as a resident of the State of Idaho, for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

Article I: Name. The name of the corporation is Idaho Stove Company, Incorporated.

Article II: <u>Duration</u>. The corporation shall endure in perpetuity.

Article III: Purpose. To sell, maintain and install stoves, fireplaces, smokers, barbeques, computers, printers, software and all aspects and endeavors related or incidental thereto, or connected therewith and doing and performing of any and all acts or things necessary, proper, or convenient for or incidental to the furthereance or the carrying out of the powers or purposes herein mentioned.
