

ARTICLES OF INCORPORATION

OF THE

WALLACE AND SUNSET RAILROAD COMPANY.

KNOW ALL MEN BY THESE PRESENTS : That We, the undersigned, Carey D. Porter, John A. Finch, Charles S. Warren, Patrick Clark, and Geo. W. Dickenson, a majority of us being freeholders within and bona fide residents of the Territory of Idaho, do hereby associate ourselves together for the purpose of forming a body politic and corporate under the laws of said Territory, and to that end, we do hereby prepare and adopt the following Articles of Incorporation :

Article.I.

The name of this Corporation shall be the "Wallace and Sunset Railroad Company."

Article.II.

The purpose for which this Corporation is formed is to build construct, equip, maintain, and operate a Steam Railroad from the Town of Wallace in Shoshone County, in said Territory, in a generally North East-erly direction and up Nine Mile Creek to a point at or near the west fork of said creek, the estimated length of said road being Five miles, together with all necessary branch lines of Railroad to be constructed, equipped and operated within said Territory, and from a point upon the main line as aforesaid, up or about any mountain, gulch, or canyon adja-cent to said Creek, for the purpose of reaching any mine or mines in territory tributary to said main line or railroad, together with all necessary sidetracks, switches, spurs, turnouts, trestles, turn-tables, and all such buildings, superstructures, substructures, machinery, appliances and facilities as may be necessary, proper or convenient for the purpose of operating said main line, and branches, the estimated length of said branches being in the aggregate Twenty miles; also, to build, erect, construct, equip and maintain overhead tramways or roads, for the purpose of connecting said main line or any branch or spur thereof with any of

said mines, the estimated length of said tramways or roads being in the aggregate Twenty miles; also, to build, erect, construct, use and maintain a telegraph line between the points and along the track lines and to any of the mine or mines hereinbefore mentioned and referred to, for the purpose of enabling said Railroad Company to properly conduct its business and operate its lines, the estimated length of said telegraph line being in all Twenty miles; and further, to exercise all the powers and functions conferred by Chapter li. of Title IV. of the Revised Statutes of said Territory, and to do and perform any act or thing incidental or cognate to the foregoing purposes or any of them.

Article.III.

The place where the principal business of said Corporation is to be transacted, is the aforesaid town of Wallace, in Shoshone County,

Article.IV.

The term for which this Corporation is to exist is hereby fixed at Fifty (50) years from and after its Incorporation.

Article.V.

The number of its Directors shall be seven, and the names and residences of those who are hereby appointed for the first year of said Company's existence are, Carey D. Porter of Wallace, Idaho; John A. Finch of Gem, Idaho; Charles S. Warren of Butte, Montana; Patrick Clark of Burke, Idaho; George W. Dickenson of Helena, Montana; Peter Porter of Wallace, Idaho, and J.K. Clark of Butte, Montana.

Article.VI.

The amount of the Capital Stock of this Corporation shall be Five Hundred Thousand Dollars, (\$500,000.00) divided into Five Thousand (5000) shares of the par value of One hundred Dollars, (\$100.00) each.

Article.VII.

That Five Thousand (5000) shares of said Capital Stock have been actually subscribed by Carey D. Porter, John A. Finch, Charles S. Warren, Patrick Clark, and George W. Dickenson.
