PRTICLE I.

That the name of this corporation is THE SAV-MOR DRUG CO. #2, THG.

*RTICLE (I.

That the purpose for which and for any of which this corporation is formed are:

- shell be the purchase and sale of personal property of all kinds, including drugs, medicines, chemicals, sanitary appliances, hospital and physician supplies and other goods and merchandise used in and pertaining to the said business including any type of merchandise usually bought and sold in drug stores and to deal in and carry on a general merchandise business and do all acts and things reasonable and necessary for the conduct of said business.
- 2. To purchase, take, lease, exchange, hire, or otherwise accuire, any real and personal property or any rights or privileges therein, which this corporation may think nemessary and conversant for the purpose of its business, and to buy, own and hold real property for the purpose of its business, and to buy, own and hold real property for the purpose of securing debts due to the corporation, and to sell and dispose of the same at will.

To purchase holdings, soll and transfer shares of its own stock, and capital stocks, bonds or other obligations of any other corporation received by it from time to time to such extent and in such menner and upon such terms and conditions as the board of directors of this corporation shall determine in order to promote the purposes of this corporation. _
