We, the undersigned, natural persons of the age of twentyone (21) years or more, acting as incorporators of a corporation
under the Utah Business Corporation Act, adopt the following
Articles of Incorporation for such corporation:

ARTICLE I

Corporate Name

The name of this Corporation is STEVE CURREY EXPEDITIONS, INC.

ARTICLE II

Duration of the Corporation

The period of duration of this Corporation is perpetual.

ARTICLE III

Purpose

The Corporation is organized to engage in any lawful business and to have and to exercise all the powers now or hereafter conferred by the laws of the State of Utah upon corporations organized pursuant to the laws of the State of Utah and any and all acts amendatory thereof and supplementary thereto and to engage in any other lawful activities.

ARTICLE IV

Shares

The aggregate number of shares which this Corporation shall

have authority to issue is 50,000 shares of common stock of a par value of One Dollar (\$1.00) per share. All shares of common stock of this Corporation shall be of the same class and shall have the same rights and preferences. Fully paid shares of common stock of this Corporation shall not be liable to any further call or assessment.

ARTICLE V

Pre-emptive Rights

The authorized shares of common stock of this Corporation may be issued at such time, upon such terms and conditions, and for such consideration as the Board of Directors of this Corporation shall determine; provided, however, that the shareholders shall have pre-emptive rights to acquire unissued shares of common stock of this Corporation.

ARTICLE VI

Voting of Shares

As to all actions to be voted on by the shareholders, each holder of common stock of the Corporation shall be entitled to one vote for each share of such stock standing in his name on the books of the Corporation, and shall not be entitled to accumulate votes for the purpose of electing directors.

ARTICLE VII

Commencing Business

This Corporation shall not commence business until consideration of a value of at least One Thousand Dollars (\$1,000.00) shall have been received by this Corporation for the issuance of its shares of common stock.

ARTICLE VIII

By-Laws

The Directors shall and the shareholders may adopt By-Laws which are not inconsistent with law or these Articles of Incorporation for the regulation and management of the affairs of this Corporation. These By-Laws may be amended from time to time, or repealed, pursuant to law.

ARTICLE IX

Registered Office and Agent

The address of this Corporation's initial registered office and the name of its original registered agent at such address is Steven C. Currey, 319 East 4000 North, Provo, Utah. 8460

ARTICLE X

Directors
