

ARTICLES OF INCORPORATION

of

Ag Decisions, Inc.

Pursuant to the provision of the Idaho Code, Section 30-1-54, the undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is Ag Decisions, Inc.

ARTICLE II

The period of the duration of this corporation is perpetual.

ARTICLE III

The purposes for which this corporation is organized is the transaction of any or all lawful business.

ARTICLE IV

The amount of the total authorized capital stock of this corporation is 10,000 shares of no-par value.

Each stockholder shall offer to the Corporation or to other stockholders of the corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock.

ARTICLE V

The name and address of the incorporator of this corporation is Gary M. Schneider, 750 I Street, Idaho Falls, Idaho 83402.

ARTICLE VI

The powers of the incorporator are to terminate upon filing of the certificate of incorporation, and the names and mailing addresses of persons who are to serve as directors until the first annual meeting of stockholders or until their successors are elected and qualify are as follows:

ARTICLE VII

The Directors shall have power to make and to alter or amend the Bylaws; to fix the amount to be reserved as working capital, and to authorize and cause to be executed, mortgages and liens without limit as to the amount, upon the property and franchise of the Corporation.

With the consent in writing, and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding, the Directors shall have the authority to dispose, in any manner, of the whole property of this corporation.

The Bylaws shall determine whether and to what extent the accounts and books of this corporation, or any of them shall be open to the inspection of the stockholders; and no stockholder shall have any right of inspecting any account or book or document of this Corporation, except as conferred by the law or the By-Laws, or by resolution of the stockholders.

The stockholders and directors shall have power to hold their meetings and keep their books, documents, and papers of the Corporation at such places as may be from time to time designated by the By-Laws or by resolution of the stockholders or directors.

ARTICLE VIII

Upon the dissolution of this corporation, its assets remaining after payments or provision for payment, of all debts and liabilities of this corporation shall be distributed amongst all shareholders in amounts proportional to their shares.


