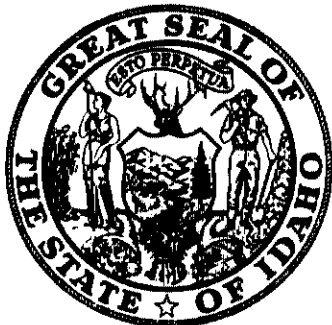
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators under the Idaho Business Corporations Act, hereby adopt the following Articles of Incorporation:

**ARTICLE ONE**

**NAME**

The name of the corporation is Sky Hi Enterprises, Inc.

**ARTICLE TWO**

**DURATION**

The duration of the corporation shall be perpetual.

**ARTICLE THREE**

**PURPOSES AND POWERS**

The corporation shall have all powers and purposes specified by the Idaho Business Corporations Act.
