



ARTICLES OF INCORPORATION

OF

QUE, Inc.

The undersigned, acting as incorporators of a corporation ation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Que, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the transaction of any and all other lawful business for which corporations may be incorporated within the State of Idaho.

FOURTH: Capital stock shall be ONE HUNDRED THOUSAND DOLLARS. The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares at a par value of one hundred dollars (100.00).

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: There shall be a restriction on the transfer of any interest whatsoever of the stock of this Corporation. Restriction on the transfer of interest shall be governed by provisions as set forth in the By-Laws.

SEVENTH: The address of the initial registered office of the corporation is 1421 Jensen, Pocatello, Idaho, 83201, and the name of its initial registered agent at such address is John D. Brokens.
