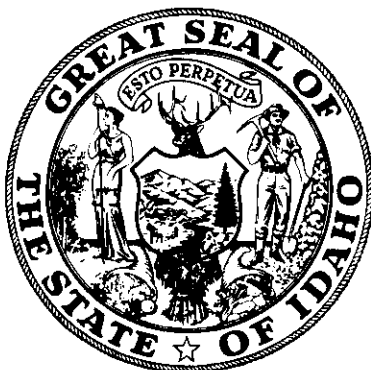

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is PARKWOOD DEVELOPMENT COMPANY.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue 5,000 shares of common stock, which stock shall have a par value of \$10.00 per share.

FIFTH: The address of the initial registered office of the corporation is 815 West Washington, Boise, Idaho 83702, and the name of its initial registered agent at such address is Colin Connell.






