COOPER, a citizen of the United States and a citizen and resident of the State of Idaho, residing at Lewiston, Idaho and whose place of business is No. 303 Main Street, its true and lawful Attorney in Fact and authorized Agent for it and in its name, place and stead to make and accept service of all writs, processes and summonses in any action, suit or proceeding in any of the courts of the State of Idaho or United States courts therein, and upon whom all lawful writs, processes and summonses may be served with the same effect as though the Company existed in the State of Idaho, requisite and necessary to give competent and complete jurisdiction of the said PACIFIC POWER & LIGHT COMPANY to any of the said courts;

GIVING AND GRANTING unto said H. W. COOPER full power and authority to do and perform every act and thing requisite and necessary to be done in and about the premises as fully to all intents and purposes as the said PACIFIC POWER & LIGHT COMPANY might or could do if personally present, hereby ratifying and confirming all that the said H. W. COOPER shall lawfully do or cause to be done by authority thereof;

HEREBY REVOKING the Power of Attorney heretofore made unto R. J. JENKS of the city of Lewiston, Idaho, and all power and authority given to the said R. J. Jenks thereunder;

This POWER OF ATTORNEY IS IRREVOCABLE except by the substitution of another qualified person for the one hereby appointed Attorney in Fact.
