

Articles of Incorporation

We, the undersigned, as proper persons acting as
incorporators of a corporation under the laws of the state of
Idaho, adopt the following articles of incorporation:

FIRST The name of the corporation is: LY-JE Corporation.

SECOND The period of its duration is: Until the shareholders decide to desolve the corp..

THIRD The purpose of the corporation is: To sell, install and maintain heating & a/c systems, to sell, install and maintain electrical wiring, and service major appliances and refrigeration systems.

FOURTH The aggregate number of authorized shares is: 100,000

FIFTH The corporation will not commence business until at least 1000.00 dollars have been received by it as consideration for the issuance of shares. Shares have no par value.

SIXTH Cumulative voting of shares of stock is authorized.

SEVENTH Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: Only original shareholders will be allowed to purchase additional shares.

EIGHTH Provisions for regulating the internal affairs of the corporation are: All actions of the corporation must be voted on by the board of directors, which must give the officers authority to act.


