

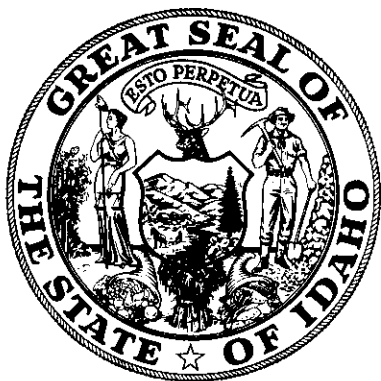
**CERTIFICATE OF INCORPORATION

Articles of Incorporation
of
Garwood Saloon, Inc.

The undersigned, acting as Incorporator of a Corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

I

The name of the Corporation is Garwood Saloon, Inc.

II

The period of duration of this Corporation shall be perpetual.

III

The purpose or purposes for which the Corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho

1. ARTICLES OF INCORPORATION

Business Corporations Act.

IV

The aggregate number of shares the Corporation shall have authority to issue is 50,000 shares, all of which are to be of no par value.

V

No stock of the Corporation shall be transferred to a person who is not already a stockholder unless the stock shall have been first offered in writing for sale to each of the other stockholders of the Corporation; if the proposed transfer is for consideration then the offer shall be at the same price and on the same terms as would govern upon a transfer to a person not a stockholder. If the proposed transfer is not for consideration, or by operation of law, then the price and terms are as set by the by laws or other resolutions of the Corporation. The writing shall set forth the price and terms and shall be sent by registered or certified mail to each stockholder at the address listed on the Corporation's books. The right to transfer the stock to a person not a stockholder shall not exist until all existing shareholders refuse the offer made as provided above, or until they fail for a period of forty-five (45)

days after receipt of the written offer to accept the same. Regulations as to the procedure and formalities of the transfer shall be prescribed in the By-laws of the Corporation.

VI

The initial registered agent of the Corporation is Sue Ann Wallace and the address of the registered agent and of the initial registered office of the Corporation is 17590 Highway 95 North, P.O. Box 751, Hayden Lake, Idaho 83835.

VII

The fiscal year of the Corporation shall be the calendar year.

VIII

The initial Board of Directors of the Corporation shall exercise all corporate powers and manage the business and affairs of the Corporation until the first annual shareholders' meeting, or until their successors be elected and qualify, whichever is later.
