The undersigned, acting as incorporator of a Corporation under the Idaho Business Corporation Act and in order to form a Corporation under the provisions of Title 30, Chapter 1, Idaho Code, submits the following Articles of Incorporation:

**Article 1:** The name of the corporation shall be: **BRENT ROBSON TRUCKING & EXCAVATION, INC.**

**Article 2:** The period of its duration is perpetual.

**Article 3:** The purpose for which the corporation is organized is to engage in and carry on a general trucking business primarily for the transporting of agricultural products of any and all kinds and every class and description; an excavation business primarily for the purpose of building of roads and normal excavation activities; and to transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporation Act.

**Article 4:** The number of shares the corporation is authorized to issue is 1000, all of one class, having no par value.

**Article 7:** The number of directors constituting the initial board of Directors of the Corporation is two (2). Members of the initial board of directors will be BRENT ROBSON and LINDA ROBSON.
