ARTICLES OF INCORPORATION

The undersigned, acting as incorporator under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is CBC, Inc.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

ARTICLE FOUR

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 20,000 in number and shall be of One and No/100ths Dollars (\$1.00) par value. Shares of stock which shall have been fully paid for shall be nonassessable.

## ARTICLE FIVE

### LOCATION

The location and address of the initial registered office of the corporation is 715 West Pacific Street, Blackfoot, Bingham County, Idaho 83221, and the name of its initial registered agent at such address is Orville W. Christensen.
