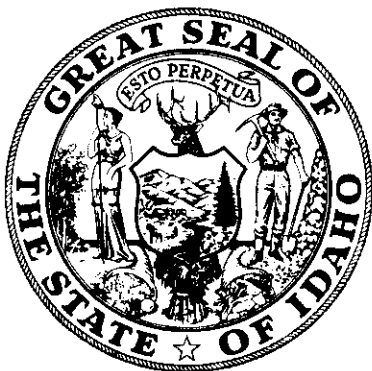

ARTICLES OF INCORPORATION
OF
WEST END VETERINARY CLINIC, P.A.

KNOW ALL MEN BY THESE PRESENTS, that we, the under-
signed being natural persons over the age of eighteen (18)
years, do hereby form a general business corporation under
the laws of the State of Idaho as contained in Title 30 of
the Idaho Code entitled "General Business Corporations Act",
and to that end do hereby set forth:

1. The name of the corporation is:

WEST END VETERINARY CLINIC, P.A.

2. The period of duration of this corporation shall
be perpetual.

3. The purposes for which this corporation is
organized are:

(a) The operation of a professional service corporation
for the rendition of veterinary medicine; and

(b) The transaction of any and all lawful business
for which a veterinary corporation organized for pursuant to the
laws of the State of Idaho.

4. The aggregate number of shares which the corporation
shall have authority to issue is 100 shares of no par value. Said
shares shall be non-assessable.

5. There shall be no pre-emptive rights to the
shareholders to purchase authorized but unissued shares of stock.

6. Ownership of the shares of stock in this corporation
shall be restricted and limited to only those persons who are duly
licensed and actually practicing veterinary medicine within the
State of Idaho.
