I, the undersigned, natural person of the age of twenty-one or more acting as incorporator of a corporation under the Professional Service Corporations Act of Idaho, Title 30, Chapter 13, of the Idaho Code, adopt the following Articles of Incorporation for such corporation.

**ARTICLE I**  
**Name of Corporation**

The name of the corporation is **MAGIC VALLEY PAIN, P.C.**

**ARTICLE II**  
**Duration**

The duration of the corporation is perpetual.

**ARTICLE III**  
**Purposes**

The purpose for which this Corporation is organized is to render professional medical services by **CHRISTIAN BECKER, M.D.**, holding license under Chapter 18 of Title 54, of the Idaho Code, and services ancillary thereto. This Corporation shall not engage in any business other than rendering the aforementioned services, provided, however, that this Corporation may own real and personal property necessary or appropriate for rendering the type of professional services for which it was organized, and may invest its funds in real estate, mortgages, stocks, bonds and other types of investments.

ARTICLE IV  
Capital Stock

The aggregate number of shares which this corporation shall have authority to issue is Fifty Thousand (50,000) shares of non-assessable voting common stock having a par value of One Dollar (\$1.00) per share. The capital stock of this Corporation shall be issued as fully paid, and the private property of the shareholders shall not be liable for the debts, obligations or liabilities of this Corporation. No shares may be issued to any person who is not an individual duly licensed to render professional services as a physician within the State of Idaho. Shares of stock of this Corporation authorized and issued pursuant to these Articles within two years from the date of incorporation are for purposes of the Internal Revenue Code authorized and issued in compliance with and as prescribed by Section 1244 of the Internal Revenue Code of 1986, and shall be known as "Section 1244 Stock."

ARTICLE V  
Commencement of Business

The Corporation will not commence business until consideration of the value of at least One Thousand Dollars (\$1,000.00) has been received for the issuance of such shares.

ARTICLE VI  
Pre-emptive Rights

Shareholders shall have no pre-emptive rights.

ARTICLE VII  
Internal Affairs

The regulation of the internal affairs of the Corporation shall be governed by the Bylaws.

ARTICLE VIII  
Registered Agent, Office and Corporation Mailing Address

The address of the initial registered agent and the office of the Corporation is 176 Falls Ave., Twin Falls, ID 83301; and the name of its registered agent at such address is Christian Becker, M.D.

ARTICLE IX  
Incorporator and Initial Director

The business of this Corporation shall be managed by its Board of Directors. The initial Board of Directors of the Corporation shall be composed of one (1) director and the name and address of the person who is to serve as director until the first annual meeting of shareholders, or until his successor is elected and qualified are:

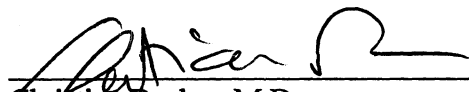
