ARTICLES OF INCORPORATION OF CHALLIS AREA CHAMBER OF COMMERCE, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are full-age citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

I.

That the name of said Corporation is: CHALLIS AREA CHAMBER OF COMMERCE, INC.

II.

That this Corporation is a NON-PROFIT CORPORATION.

III.

The period of existence and duration of the life of this Corporation shall be perpetual.

IV.

The address of initial registered office of this Corporation is Challis Area Chamber of Commerce, Inc., 1130 North Main, P. O. Box 540, Challis, Idaho 83226, and the name of the initial registered agent at such address is SCOT TAPPAN.

٧.

The purposes for which this Corporation are formed are as follows:

- (a) The advancement of the civic, commercial, industrial and agricultural interest of the City of Challis, and the surrounding territory.
- (b) The promotion of the general welfare and prosperity of the city, county and its surrounding territory, and the stimulation of public sentiment to these ends, and the providing of such social features as will promote these purposes.

VI.

The management and the corporate power of this Corporation shall be vested in and exercised by the Board of Directors, except as otherwise provided in the By-Laws, or as otherwise provided by law.

VII.

The first Board of Directors shall consist of five (5)

directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the By-Laws.
