ARTICLES OF INCORPORATION

of

1. The name of the corporation is Olympic Printing, Inc.
2. The period of its duration is perpetual.
3. Its purpose of the corporation is to transact the business of all lawful activity which a corporation may conduct under the laws of the State of Idaho.

4. The corporation shall have authority to issue 10,000 shares of common stock, all of which shares shall be \$1.00 par value.

5. The address of the corporation's initial registered office is 10383 Fairview Ave., Boise, Idaho 83704. The name of its official registered agent at such address is Michael Montgomery.

6. The number of directors constituting the initial board of directors of the corporation is one whose name and address is:

The personal liability of a director to the corporation or its stockholders for monetary damages for breach of fiduciary duty as director is hereby eliminated and no director shall have personal liability to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except that the personal liability of a director to the corporation or its stockholders for any breach of the directors duty of loyalty to the corporation or its stockholders, for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law shall not be eliminated and the personal liability of a director to the corporation or its stockholders for the liability imposed by Idaho Code 30-1-48 shall not be eliminated and the personal liability of a director to the corporation or its stockholders for personal liability for any transaction from which the director derived a legally improper personal benefit shall not be eliminated.
