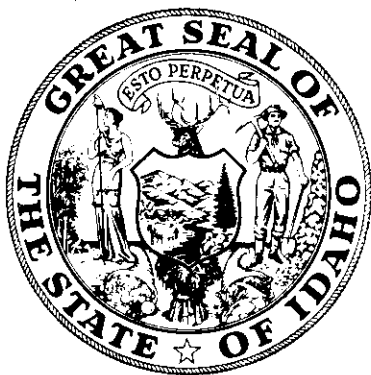

EXHIBIT "A"

ARTICLES OF AMENDMENT

The following amendments are those referred to in the attached Articles of Amendment:

AMENDMENT NO. 1:

Article Seven is deleted in its entirety and replaced by a new Article Seven to read as follows:

The total number of shares of stock which the corporation shall have authority to issue shall be 500 shares of the par value of One Dollar(s) (\$1.00) each, amounting in the aggregate to Five Hundred Dollars and No Cents (\$500.00).

No shareholder shall be entitled as a matter of right to subscribe for or receive additional shares of any class of stock of the corporation, whether now or hereafter authorized, or any bonds, debentures or other securities convertible into stock, but such additional shares of stock or other securities convertible into stock may be issued or disposed of by the Board of Directors to such persons and on such terms as in its discretion it shall deem advisable.

AMENDMENT NO. 2:

Amendment No. 1 and Amendment No. 2 of the Articles of Amendment, filed with the Secretary of State of the State of Idaho on November 7, 1985, are deleted in their entirety.
