## ARTICLES OF INCORPORATION

of

# PERRAULT AERO TECHNOLOGY CORPORATION

KNOW ALL MEN By these presents that we, citizens of the United States of America of full legal age, having this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and to that end do hereby adopt Articles of Incorporation as follows:

# ARTICLE I

The name of the proposed corporation is Perrault Aero Technology Corporation.

## ARTICLE II

The nature of the business and the object and purposes proposed to be transacted, promoted, and carried on are to do any and all things herein mentioned as fully and to the same extent as natural persons might or could do in any part of the world, to wit: To build, develop and construct airplanes, parts, equipment, offices, commercial buildings, and structures and to purchase, lease, buy and option real estate for the development of same, to build for, rent to, lease to, or sell to individuals, partnership, corporations, utilities, government entities, and businesses, and to acquire, purchase, lease, buy, or otherwise hold, own, sell, lease, mortgage, and otherwise dispose of both real property and buildings, and structures; to purchase, buy

lease, and rent equipment, supplies, materials and property necessary to construct, develop, maintain and operate said business and to engage in contracting, management, leasing and purchasing.

To make estimates and bid upon, enter into, and carry out contracts, leases and agreements with the renting, leasing, management, development, construction, of said real property, and building to private parties, contractors, utilities, partnerships, corporations, municipal entities, and to acquire, use, employ, sell and deal with and in all suitable means, apparatus, machinery, contrivances, equipment and facilities for the prosecuting of this business.

To take, own, hold, deal in, mortgage, otherwise lien, and to lease, sell, exchange, transfer, or in any manner whatso-ever acquire and dispose of buildings, and of real property within or without the State of Idaho, wheresoever situated.

To buy, hold, acquire, transfer, own, dispose of, construct, erect, develop and deal in property of any and every class and description, and in any part of the world.

To acquire the goodwill, rights, and property, and to undertake the whole or any part of the assets, liabilities, of any person, firm, association or corporation, and to pay for the same in cash or the stock of this company, or bonds or otherwise to hold, or in any manner dispose of the whole or any part of the property so purchased; to conduct in any lawful manner the whole or any part of any business and property so acquired and to exercise all the powers necessary and convenient in or about the conduct and management of such business.

To enter into, make and perform contracts of every kind with any person, firm, association or corporation, municipality, public body, county, territory, state, government or colony, or

dependency thereof, and without limit as to the amount to draw, make, accept, endorse, discount, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures and other negotiable and transferrable instruments and evidence of indebtedness whether secured by mortgage or otherwise as well as to secure the same by mortgage or otherwise as may be permitted by the laws of the State of Idaho.

To hire, employ, contract with, enter into agreements with, let and sublet to, and obtain services in any manner whatsoever of persons, individuals, firms, businesses, corporations, partherships, and governmental and municipal entities as may be necessary to conduct the business.

To have offices, conduct its business and promote its objectives within or without the State of Idaho and other states, the District of Columbia, the territories and colonies of the United States and in foreign countries without restriction as to place or amount.

To do any or all of the things set forth herein to the same extent as natural persons might or could do in any part of the world as principals, agents, contractors, trustees or otherwise and either alone or in company with others.

In general, to carry on any other business with connection therewith whether in construction, holding of real property, or otherwise, not forbidden by the State laws of the State of Idaho, and with all the powers conferred upon corporations by the State of Idaho.
