ARTICLES OF INCORPORATION

of

R. I. ROBINSON HONEY COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States of America, residents of the State of Idaho and the County of Canyon, and of lawful age, this day having voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the Business Corporation Act and related laws of the State of Idaho, do hereby certify:

ARTICLE I

Name

The name of this corporation shall be

"R. I. ROBINSON HONEY COMPANY, INC."

ARTICLE II

Purpose

- (a). To engage in a general manufacturing business; to manufacture, make, sell, transport, buy and otherwise deal in various kinds of bee-keeper's supplies, such as hives, supers, frames, sections, honey shipping cases, honey containers, comb foundation, and various devices and parts incidental to the manufacturing and sale of such goods; to purchase, sell, transport, and otherwise deal in honey, beeswax, bees, and such products; to maintain apiaries and the production of bees, honey, wax and other products incidental thereto;
- (b). To buy and sell on commission or otherwise, at wholesale or retail, honey, beeswax, bees and such products; to manufacture the products obtained from honey and like materials and to produce and otherwise deal in bees and bee equipment, in the State of Idaho and elsewhere.

- (c). To purchase or acquire in any lawful manner and to hold, own, mortgage, pledge, sell, transfer, or in any manner dispose of, and to deal and trade in real estate, water rights, stocks, bonds, merchandise, livestock, and property of every kind and any and every class and description, and in any part of the world.
- (d). To purchase and sell the good will, rights and property, and to undertake the whole or any part of the assets or liabilities of any person, firm, association or corporation; to pay for the same in cash, the stock of this company, bonds, or otherwise; to hold or in any manner to dispose of the whole or any part of the property so purchased; to conduct in any lawful manner the whole or any part of any business so acquired, and to exercise all the powers necessary or convenient in and about the management of such business.
- (e). To apply for and purchase, or in any manner to acquire, and to hold, own, use and operate, and to sell or in any manner dispose of, and to grant license or other rights in respect thereof, and in any manner to deal with, any and all rights, inventions, improvements and processes used in connection with or secured under letters patent or copyrights of the United States or other countries, or otherwise, and to work, operate or develop the same, and to carry on any business, manufacturing or otherwise, which may directly or indirectly effectuate these objects or any of them.
- (f). To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of the capital stock of, or any bonds, securities or evidences of indebtedness created by any other corporation or corporations of this state, or any other state, country, nation or government, and while owner of

said stock may exercise all the rights, powers, and privileges of ownership, including the right to vote thereon, to the same extent as natural persons might or could do.

- kind with any person, firm, association or corporation, municipality, body politic, country, territory, state or government, and without limit as to amount to draw, make, accept, endorse, discount, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and other negotiable or transferable instruments and evidences of indebtedness whether secured by mortgage or otherwise, as well as to secure the same by mortgage or otherwise.
- (h). To conduct business in any of the states, territories, and otherwise, of the United States, in the District of Columbia, and in any and all foreign countries, to have one or more offices therein, and therein to hold, purchase, mortgage and convey real and personal property, without limit as to the amount.
- (i). To do any and all things herein set forth to the same extent as natural persons might or could do in any part of the world, as principals, agents, contractors, or otherwise, and either alone or in company with others.
- (j). To purchase, hold, and reissue any of the shares of its capital stock.
- (k). In general to carry on any other business in connection therewith of every kind not forbidden by the laws of the State of Idaho and with all the powers conferred upon corporations by the laws of the State of Idaho.

The foregoing clauses shall be construed both as objects and powers, but no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive, but it is hereby expressly declared that all other lawful powers not inconsistent therewith are hereby included.

ARTICLE III

Duration

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE IV

Place of Business

The location and post office address of the registered office of this corporation in the State of Idaho, shall be: 904 So. Powerline Road, Nampa, Canyon County, Idaho.

ARTICLE V

Stock

This corporation is authorized to issue one class of shares of capital stock and shall be designated as common stock;

The total number of shares of common stock this corporation shall be authorized to issue is 1,000 shares;

The par value of each of the shares of common stock shall be \$100.00;

The aggregate par value of the shares of this corporation shall be \$100,000.00.

ARTICLE VI

Directors

The number of directors of this corporation shall be at least three (3), and such additional number of directors as may be

ARTICLE VIII

Stockholders' Liability

The capital stock of this corporation shall be non-assessable, and the private property of the shareholders in this corporation shall not be liable for the debts, obligations and liabilities of this corporation.

ARTICLE IX

Powers

The Board of Directors of this corporation shall have the power to repeal and amend the by-laws of this corporation and adopt new by-laws. Such power shall not extend to making or altering any by-laws, fixing the qualifications, classifications, term of office or compensation of the Board of Directors and this authority shall not be interpreted as taking from the shareholders that power and authority given to them by Section 30-133 Idaho Code, 1947, its amendments and additions.
