That pursuant to Idaho Code 30-160, the Trustees of the Friends Church of Star did execute in writing a document entitled "Consent to Extension of Corporate Existence", making the existence of said corporation perpetual, and amending the Articles of Incorporation to conform thereto; that a true and correct copy of said document is in words and figures as follows; to wit:

"TRUSTEES' ASSENT TO

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being a majority of and representing all the Trustees of the Friends Church of Star, a corporation organized and existing under and by virtue of the laws of the State of Idaho, do hereby give our written assent, pursuant to the provisions of Idaho Code 30-160, that the existence of said corporation be extended and made perpetual, and do further assent and agree that Article IV of the Articles of Incorporation be, and the same is hereby amended to read as follows, to wit:

'ARTICLE IV.

That the term for which this corporation shall exist is perpetual."

We do hereby further authorize the officers and Trustees of the corporation to take all further steps and acts necessary to effect the extension of the corporation's existence, and the amendment of the Articles of Incorporation as hereinabove provided.
