## ARTICLES OF INCORPORATION OF CHAMPIONSHIP ENTERPRISES, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is CHAMPIONSHIP ENTERPRISES, INC.

II.

The period of duration of the corporation shall be perpetual.

III.

The purpose or purposes for which the corporation is organized is for the transaction of any and all lawful business for which corporations may be incorporated under this act.

IV.

The authorized capital stock of this corporation shall consist of 500,000 shares of common stock having a par value of ONE CENT (\$.01) per share and an aggregrate par value of FIVE THOUSAND DOLLARS (\$5,000.00); all of said shares shall be issued fully paid and shall not be subject to assessment.

V.

The private property of the shareholders shall not be subject to the payment of corporate debts to any extent whatsoever. This corporation shall commence doing business once at least ONE THOUSAND DOLLARS (\$1,000.00) has been received as consideration for the issuance of capital stock.

The address of the initial registered office of the corporation is 1027 E. 5th Street, Moscow, Idaho, 83843, and the name of the initial registered agent at such address is KENNETH L. ROELEN.

VII.

This corporation shall have the power and authority to buy its own stock and hold the same as treasury stock or to sell or otherwise dispose of the same.

VIII.

The number of directors constituting the initial Board of Directors of this corporation is one (1). The name and address of that person who shall serve as director until the first annual meeting of shareholders or until his successor is elected and qualified is KENNETH L. ROELEN, 1027 E. 5th Street, Moscow, Idaho, 83843.
