

## ARTICLES OF INCORPORATION

OF

## KLAUS WIEBE LAW OFFICES, P.A.

The undersigned, a natural person acting as an incorporator in order to form a corporation under the provisions of the Idaho Professional Service Corporation Act, adopts the following Articles of Incorporation:

Article 1. <u>Name.</u> The name of the corporation is Klaus Wiebe Law Offices, P.A.

Article 2: <u>Purposes and Objects</u>. The purposes and objects for which the corporation is formed are:

 a) Primarily to engage in the specific business of the practice of law as a law corporation;

b) To engage generally in the business of a law corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;

 c) To engage in such other business as may be authorized or permitted by the Idaho Business Corporation Act, subject to any
ARTICLES, P. 1 limitation imposed by any provision of the Idaho Professional Service Corporation Act.

Article 3. <u>Duration</u>. The corporation is to have perpetual existence.

Article 4. <u>Registered Office and Agent.</u> The location and street address of the initial registered office of the corporation is 1523 West Hays Street, Boise, Idaho 83702. The initial registered agent of the corporation shall be Klaus Wiebe who conducts business at the above address.

Article 5. Aggregate Shares. The aggregate number of shares which the corporation shall have the authority to issue is 50,000 shares of \$1.00 par value, all of which shares are to be of the same class.

Article 6. <u>Initial Incorporator</u>: The name and post office address of the incorporator is as follows:

Article 7. <u>Initial Directors.</u> The number of directors constituting the initial Board of Directors of the corporation shall be and is one. The names and post office addresses of the initial Directors, who are to serve until the first annual meeting of the stockholders and until their successors are elected and shall qualify, are as follows:

Article 8. Limitation on Issue and Transfer of Shares: None of the capital stock of this corporation shall be issued to anyone other than an individual duly licensed to practice law in the State of Idaho, and no shareholder of this corporation may sell or transfer his shares in this corporation except to another individual who is eligible to be a shareholder of this corporation pursuant to the provisions of the Idaho Professional Service Corporation Acct. Additional restraints on the alienation of shares and provisions governing the purchase or redemption by the corporation of its shares of corporate stock may also be adopted by the Board of Directors or thee shareholders of this corporation.

Article 9. <u>Amendment of Articles and By-Laws</u>. The initial By-Laws of the corporation shall be adopted by the majority of the Board of Directors. A majority of the Board of Directors of shareholders shall have the power to alter, amend or repeal the By-Laws or adopt new By-Laws. The corporation reserves the right to amend, alter or repeal these Articles of Incorporation in the manner prescribed by law, by a majority vote the stockholders.
