The undersigned, as incorporator of the above corporation, adopts the following Articles of Incorporation for such corporation as follows:

ARTICLE I

NAME

The name of the corporation is EAGLE TRANSFER/TRINACO, INC..

ARTICLE II

Period of Duration

The period of duration of this corporation is perpetual.

ARTICLE III

Purpose

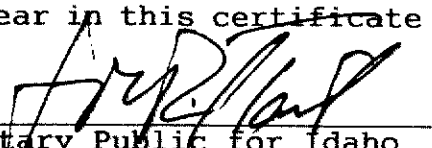
