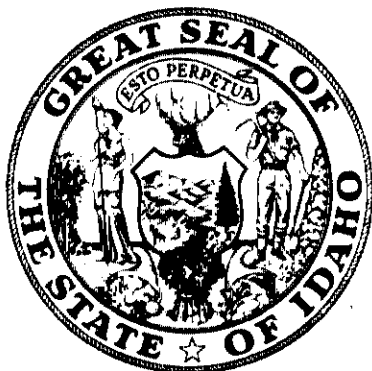

All remaining property and assets of the Corporation have been distributed among the shareholders in proportion to their respective rights and interests.

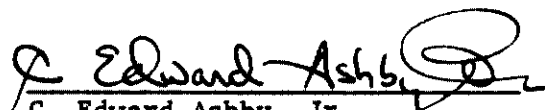

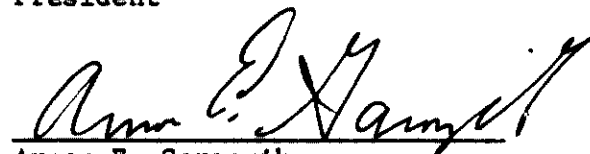
With the sole exception of the lawsuit captioned Union Pacific Railroad Company v. Puerto Rico Electric Power; Hasman and Baxt, Inc., Samson Truck Lines and Richard L. Edgar, d/b/a/ Samson; T. R. Compton, Inc., and Wes Con, Inc., and Gene Rinebold, d/b/a Wes Con, Inc. filed in the United States District Court for the District of Idaho, case No. 81-4109, there are no suits pending against the Corporation in any court. With respect to the aforementioned lawsuit, adequate provision has been made for the satisfaction of any adverse judgment in that the Guaranty Indemnity Insurance Company has accepted the tender of the Corporations defense in this lawsuit and has agreed to indemnify the Corporation from any loss arising thereunder.

Article VIII

The dissolution is pursuant to a resolution adopted in the manner required by Section 30-1-84, Idaho code.
