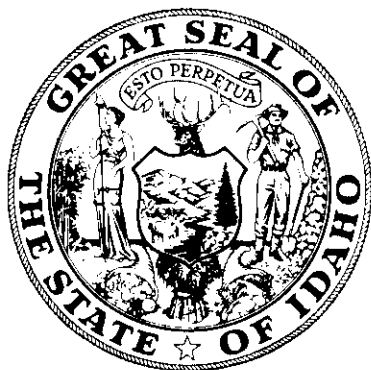

ARTICLES OF INCORPORATION
OF

KNOW ALL MEN BY THESE PRESENTS, that we, DAVID P. VOLKING and PATRICIA L. VOLKING, all of whom are of legal age, and have this day voluntarily associated ourselves together for the purpose of forming a coproration under and pursuant to the laws of the State of Idaho and we do thereby certify:

I.

That the name of this corporation shall be

II.

That the duration and existence of this corporation shall be perpetual.

III.

That the purposes of this corporation as formed are as follows:

To engage in all phases of manufacturing, distributing, selling, installing and otherwise dealing in heating and air-conditioning equipment and materials, and in the heating, air-conditioning and sheet metal business for both residential and commercial usage, and to engage in all other forms of


