ARTICLES OF INCORPORATION

OF

MISKIN SCRAPER WORKS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, Arthur R. Miskin, Luvina V. Miskin, Merlin R. Miskin and Gilbert E. Miskin, of Ucon, Bonneville County, Idaho, all being persons of full age and citizens of the United States, do hereby, as incorporators thereof, form a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt Articles of Incorporation of such corporation as follows:

I.

That the name of said Corporation is Miskin Scrapper Works, Inc.

II.

That the purposes for which said corporation is formed are as follows:

To manufacture and assemble all kinds and varieties of farming and mechanical and hydraulic machinery and in conjunction therewith to manufacture, construct and deal in machinery, appliances and plants of every nature, kind and description whatsoever.

To sell, import, export, vend, trade, distribute, store, repair, purchase, lease or otherwise acquire or dispose, and to manufacture and construct machines of any kind or character and to equip and erect such machines for use and operation by electricity, compressed air, mechanical means, oil, gas, atomic or by any other means of motive power, and to operate, use, sell, lease and hire the same. To apply for, or purchase, or otherwise acquire, and to grant licenses for the use, or to sell, assign or otherwise deal in and use patents, patent rights, privileges, licenses, trademarks, trade names, devices and improved or secret processes of every sort and description, necessary and incidental to these purposes.

To carry on a general manufacturing, wholesale and retail merchandise business and to specifically carry on the business of manufacturing Miskin scrapers, steel bob sleds and baled hay forks.

To act as agent for any manufacturer or distributors in the buying and selling of all kinds of articles, goods, merchandise, parts, sundries, farm implements, trucks and other mechanically propelled or motor or power driven vehicles or conveyances and other kinds of implements and machinery, accessories, or any of the other articles, matters or things enumerated in these Articles, and to enter into contracts with any such manufacturers or distributors relative to such agency or agencies.

To acquire, hold, possess, and own patents, copyrights, improvements and franchises, or to acquire licenses under any of them, for the manufacture and sale of any of the matters and things enumerated in these Articles, and to beneficially use rights under such patents by vending said patents and rights or licenses thereto;

To borrow money, to issue bonds, debentures and other obligations of the corporation and to mortgage or pledge its property to secure such borrowed money or other obligations.

To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease real and personal property; to dispose of, sell, lease, assign, transfer, mortgage, and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to

acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge, and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign.

Particularly, to have all the powers or authority authorized and provided for by Section 30-114 of the Idaho Code.

To exercise and perform any and all of the hereinbefore mentioned and described powers and matters within and/or without the State of Idaho.

III.

That the duration of said corporation shall be perpetual.

IV.

That the location and post office address of the registered office of said corporation in Idaho, shall be Ucon, in Bonneville County, Idaho.

V.

That the shares of stock of said corporation are not to be classified and shall all be common stock, and that the authorized shares of said corporation shall be 10,000 in number, of the par value of \$10.00 each and of the aggregate par value of \$100,000.00.

That said shares of stock shall be fully paid up before being issued and said issuance shall be non-assessable.

VI.


