## **Article 8: Distribution of Assets**

Under the dissolution of the GenTree Project Association, Incorporated, assets shall be distributed to the Genesee Recreation District (Genesee, Idaho). If, at the time of dissolution, the Genesee Recreation District no longer exists, assets shall be distributed to the City of Genesee (Genesee, Idaho) government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
