ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full legal age, and all citizens of the United States and residents of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

1.

The name of the corporation is KOYLE IMPLEMENT CO.

2.

The purposes for which this corporation is formed are as follows: to establish, maintain and conduct general mercantile implement agencies, to carry on every branch of business usually transacted in connection therewith, including the obtaining and acquiring by purchase, or any other lawful manner, information, statistics, facts and circumstances of, relating to, or affecting the said business, to purchase for sale all manner of farm equipment, including farm machinery, water pumps of any kind or nature, hardware, electric appliances, motors, and supplies, ordinarily and usually used in the raising of farm produce and to carry all necessary parts and supplies for the repair and maintenance of all kinds of farm machinery; to buy, sell, barter, exchange and generally deal in all classes of goods, wares, and merchandise in any manner involved in farming operations, including lumber, shingles, and other articles of trade or for sale; to lease buy and otherwise acquire real estate and personal property and to lease, sell and dispose of the same and to do all things necessary or convenient for the carrying out of the main purposes and objects of the organization of the corporation.

3.

The corporation shall have a perpetual existence.

4.

The location and post office address of the registered office of said corporation shall be Rupert, Minidoka County, Idaho, or at some other place in Idaho, as the Directors may hereinafter determine.

The capital stock of said corporation shall be one hundred thousand dollars (\$100000.00) to be represented by 100000 shares of stock. The said stock shall be in the denomination of \$1.00 each. All of said stock issued by said corporation shall be common capital stock and shall be of the par value of \$1.00 per share.
