ARTICLES OF INCORPORATION  
OF  
DODDS INSURANCE AGENCY, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, A. K. DODDS, AMY LOUISE DODDS, and A. L. BLANDFORD, residents of the County of Twin Falls, State of Idaho, each and all being of the age of majority and citizens of the United States of America, do hereby associate themselves together for the purpose of incorporating under the laws of the State of Idaho, and to that end do hereby adopt and execute the following Articles of Incorporation, and DO HEREBY CERTIFY AND DECLARE:

I.

That the name of this corporation shall be DODDS INSURANCE AGENCY, INC.

II.

That the purposes for which this corporation is formed are as follows:

To carry on the business of selling and writing life and casualty insurance; to deal in and with contracts which undertake to indemnify another or pay or allow a specified or ascertainable amount or benefit upon determinable risk contingencies; to do all acts and to transact all business authorized by the Insurance Code of the State of Idaho or by the laws of any other state; and to carry on and conduct any other business incidental thereto within the District of Columbia, the State of Idaho, and such other states in which the corporation may hereafter be authorized to conduct business.

To buy and sell, and otherwise acquire, own, hold, use, assign, transfer, lease, mortgage, pledge, or otherwise dispose

of real and personal property of every kind and description whatsoever.

To do any and all acts designed to protect, preserve, improve or enhance the value of any property at any time held or controlled by this corporation or in which it may at any time be interested.

To enter into, make, perform and carry out contracts or obligations for any lawful purpose.

To borrow and lend money and to secure the same by mortgage, pledge, or otherwise, upon the real and personal property owned by this corporation.

To sue and be sued.

To acquire by purchase or otherwise any bonds, securities, debentures, other evidences of indebtedness, or shares of capital stock in this or other corporations.

To carry on any business that is adapted directly or indirectly to add to the value of the real or personal property of this corporation.

### III.

That the location and post office address of the registered office and place where the principal business of this corporation is to be transacted is Kimberly, County of Twin Falls, State of Idaho.

### IV.

That the amount of the authorized capital stock shall be \$50,000.00, divided into 1,000 shares of common stock, 300 shares thereof with a par value of \$155.00 each, and 700 shares thereof with a par value of \$5.00 each.

V.

That each share of the capital stock of this corporation shall be entitled to one (1) vote.

VI.

That the amount of the capital stock of this corporation which has been actually subscribed is \$15.00, and the following are the names of the subscribers and incorporators, their addresses, and the number and par value of the shares subscribed by each:



VII.

That, subject to dissolution in the manner provided by law, the term of existence of this corporation shall be perpetual.

VIII.

That in all cases and for all intents and purposes the value of each share of capital stock of this corporation shall be in proportion to the par value thereof and not in proportion to the number of shares; and in the event of the dissolution of this corporation the stockholders of the corporation holding stock on the date of such dissolution shall share ratably in the surplus of the corporation property, remaining after payment of all debts and claims against the corporation, in proportion to the par value of the shares of stock at time of dissolution and not in proportion to the number of shares of stock held by each stockholder.


