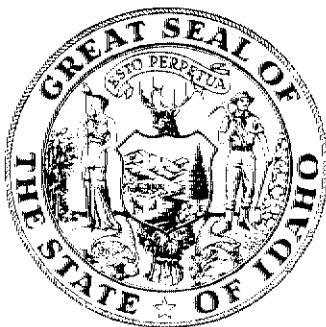

The undersigned, Mohammad Alidjani, being the sole shareholder of Sanitary Service, Inc., does hereby certify, declare and adopt the following Amended Articles of Incorporation:

1. The name, location and address of the registered agent and registered office of this corporation shall be as follows:

2. The corporation is authorized to issue up to one thousand (1,000.00) shares with no par value. No distinction shall exist between the shares of this corporation and all such shares shall have the same rights in the corporation.
3. The power to alter, amend, or repeal the By-Laws of this corporation shall be vested in the shareholders, by the affirmative vote of the holder or holders of a majority of the issued and outstanding shares of the corporation.
4. The original Articles of Incorporation previously filed by the Secretary of State on November 19, 1958 are hereby amended and replaced as set forth herein.
5. The corporation reserves the right to further amend, alter, change or repeal any provisions contained in these articles of incorporation in the manner now or

hereafter prescribed by statute, and all rights conferred upon stockholders herein are granted, subject to this reservation.
