The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

The name of the corporation is ROBERT JACOBSON: DESIGN, LTD.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are:

To conduct the business of designing, publishing and distributing educational posters together with related services and materials.

To conduct any and all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

The aggregate number of shares which the corporation shall have authority to issue is ONE HUNDRED THOUSAND DOLLARS (\$100,000.00), which shall be divided into One Hundred Thousand (100,000) shares of common stock, the par value of each share shall be One Dollar (\$1.00), and such stock shall be nonassessable.
