The undersigned natural person, being at least eighteen years of age, acting as incorporator, hereby establishes an Idaho corporation pursuant to the Idaho Business Corporation Act, Idaho Code Ann. §§ 30-1-101 et seq., (the "Act"), and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Just Wing It, Inc. (hereinafter the "Corporation").

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

ARTICLE III

PURPOSES, POWERS AND PROFESSION TO BE PRACTICED

(a) **Purposes.** The purposes for which the Corporation is organized are to own and lease real and personal property, and to engage in any other lawful acts, activities and pursuits for which a corporation may be organized under the Act.

(b) **Powers.** In furtherance of the foregoing purposes and objectives, and subject to the restrictions set forth in the Act, the Corporation shall have and may exercise all of the powers now or hereafter conferred upon Corporation organized under the laws of Idaho and may do everything necessary or convenient for the accomplishment of any of the corporate purposes, either alone or in connection with other organizations, entities or individuals, and either as principal or agent, subject to such limitations as are or may be prescribed by law.

ARTICLE IV

SHARES OF STOCK

The Corporation shall have authority to issue Two Thousand (2,000) shares of stock which stock shall be of one class only which shall be common voting stock. Shares may only be issued to persons meeting the requirements of the Act. The common stock shall have unlimited voting rights as provided in the Act and shall be entitled to rescue the net assets of the Corporation upon dissolution.

ARTICLE VI

DIRECTORS

The management of the affairs of the Corporation shall be vested in a Governing Board of Directors, except as otherwise provided in the Act, these Articles of Incorporation or the Bylaws of the Corporation. The number of directors, their classifications, if any, their terms of office and the manner of their election or appointment shall be determined according to the Act and the Bylaws of the Corporation as they may be amended from time to time. Two directors shall constitute the initial Governing Board of Directors. The names and addresses of the initial directors are as follows:
