

AMENDATORY ARTICLES OF INCORPORATION OF A. LUDLOW KRAMER

They are the President and Secretary, respectively, of S. S. MULLEN INCORPORATED.

At a meeting of the shareholders duly called upon notice of the specific purpose, the holders of all the voting power of all shareholders of S. S. MULLEN INCORPORATED did make, subscribe, certify and adopt the following amendment to the Articles of Incorporation changing the name of the corporation:
