



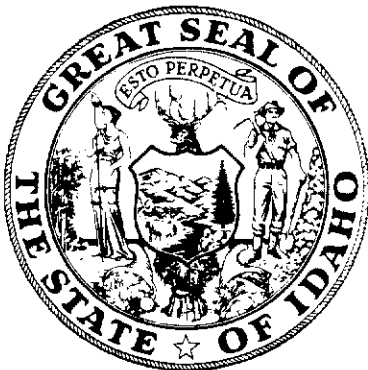
CERTIFICATE OF WITHDRAWAL

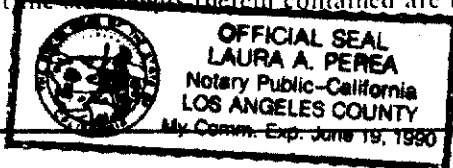
1. The name of the corporation is Shaughnessy Operations Corporation
