

**ARTICLES OF INCORPORATION  
OF  
BUSINESS LINK SYSTEMS, INC.**

The undersigned person, being at least eighteen (18) years old and acting as incorporator, in order to form a Corporation under the provisions of Title 30, Chapter 1, Idaho Code, submits the following articles of incorporation to the Secretary of State:

**ARTICLE 1  
NAME**

The name of the Corporation shall be: BUSINESS LINK SYSTEMS, INC.

**ARTICLE 2  
AUTHORIZED SHARES**

The Corporation shall have authority to issue One Hundred Thousand (100,000) shares of common stock, without par value, and shall not have authority to issue any other class of shares or series of shares within the class. All voting rights of the Corporation shall be exercised by the holders of common stock, and the holders of common stock shall be entitled to receive the net assets of the Corporation upon dissolution.

**ARTICLE 3


**ARTICLE 6**  
**PURPOSES AND POWERS**

The Corporation is organized to engage in any and all lawful acts and activities for which corporations may presently or hereafter be organized under the provisions of Title 30, Chapter 1, Idaho Code. The Corporation shall have all powers allowed by law, including but not limited to the powers described in the provisions of Title 30, Chapter 1, Idaho Code as amended from time to time.

**ARTICLE 7**  
**LIMITATION ON LIABILITY OF DIRECTORS**


No director of the Corporation shall be liable to the Corporation or its shareholders for monetary damages for any action taken or any failure to take any action as a director, except liability for (a) the amount of a financial benefit received by a director to which he or she is not entitled, (b) an intentional infliction of harm on the Corporation or its shareholders, (c) a violation of section 30-1-640, Idaho Code, or (d) an intentional violation of criminal law. Any repeal or modification of this Article V by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
