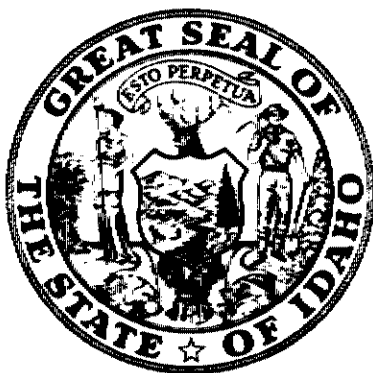

The sole director, the sole shareholder, the President, the Secretary, and the Treasurer of the corporation is




