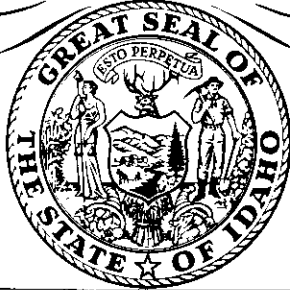

ARTICLES OF INCORPORATION

OF

THE CONDOR COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all natural persons and of legal age, and all citizens of the United States and two residents and citizens of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

1.

The name of the corporation is The Condor Company.

2.

The purpose for which said corporation is formed is as follows: To own, manage, operate, buy and sell agricultural real estate and to lease, purchase, and manage all kinds of live stock, to raise, distribute, market and transport agricultural crops, to raise, purchase, sell and transport all kinds of livestock, feed and transport livestock to and from markets and to and from places of feeding and grazing, to purchase hold and sell such real and personal property as may be necessary to the prosecution of said business and to do whatever may be necessary in the operation and managing of the farming and livestock business including the transportation of farm products and livestock.

The corporation is to have a perpetual existence.

4.

The location and post office address of the registered office of said corporation is Bridge, Cassia County, Idaho.



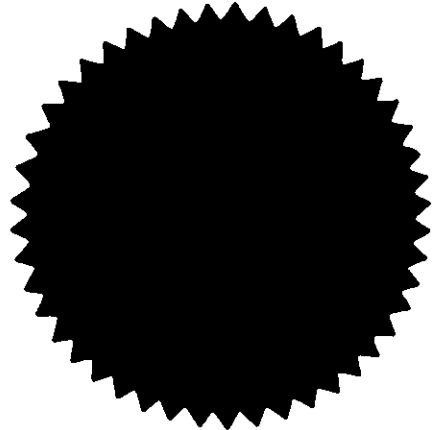
